David A. Rameden, a long time member and former president of the Earl E. O'Connor Inn of Court, passed away unexpectedly on February 26, 2012 while vacationing with his wife in Nevada. A Celebration of Life for Dave was held March 10 and was attended by many members of our Inn.

Dave's brilliance was apparent to everyone who had the pleasure of meeting him. He was valedictorian of his high school class in Forest Lake, Minnesota, and a graduate of the United States Military Academy at West Point. After receiving a B.S. degree in Operations Research from Stanford University, he returned to West Point as an associate professor of mathematics. He concluded his military career as Operations search and Systems Analyst at Fort Leavenworth, Kansas. Dave then entered UMKC's Joint Law and MBA program, graduating at the top of his class. He joined Shook, Hardy and Bacon, LLC where he became a partner specializing in anti-trust and other complex business litigation. In addition to serving as a former president of our Inn, Dave was past president of the Kansas Association of Defense Counsel and a member of the Defense Research Institute.
