Mentoring

Here are the top five things that Mentoring Co-Chairs, **Donna Eng** of Carbolic Smokeball and **Terrill Pyburn** of Gray's Inn, want you to know about mentoring:

- 5. Formal mentoring is worth 50 points toward the INNy Cup. It is mentoring that takes place between the mentors and mentees that have been formally paired together based on practice area. Formal mentoring involves lengthy substantive discussions or general guidance as part of an ongoing relationship.
- 4. Informal mentoring is worth 20 points toward the INNY Cup. It is mentoring by telephone, over the Internet, or in person. This type of mentoring promotes general networking within the Inn in that it is not facilitated through the formal mentoring groups and can involve any Inn members.
- 3. No points toward the INNy Cup are available for mentoring outside the Inn, although a laudable practice.
- 2. Make sure to report mentoring sessions on the form provided to your pupillage group leader at the monthly meetings in order to earn points toward the INNy Cup.
