The Pupilage Group Program

Our Inn's core program is the Pupilage Group Program. Every member of the Inn is assigned to one of at least five Pupilage Groups, and each Group is responsible for organizing the program for one of our monthly meetings. The Pupilage Group programs are intended to educate and inform our members as to

cutting edge developments in the field of intellectual property law, or to otherwise further the general goals of the American Inns Movement. Each Pupilage Group will be led by Program Chairs, who will coordinate the Group's efforts in preparing the program. Pupilage Group assignments are in progress and will be announced at our first meeting.

The Q. Todd Dickinson Website and Membership Handbook

New this year, we have appointed Richard Graham and David DuMont as Website Co-Chairs for our Inn. They have worked hard over the summer to update our Inn website. We have also updated our Membership Handbook which is now available on our website. The Handbook provides the basic information you will need to be an active part of the Inn. The Q. Todd Dickinson Mentor Program

Mentoring is a fundamental aspect of the American Inns Movement. Although we have informally practiced a mentoring environment within our Pupilage Group in our past year programs, we plan to pilot a more formal Mentoring Program this year, through which judges and experienced practitioners can mentor newer attorneys and students from our participating law schools. We have appointed Chris Verdini and Alicia Passerin to serve as our Inn's Mentor Program Co-Chairs. You'll find a Mentoring Program registration form in our Handbook, which you can use to sign up to ask that you be assigned a mentor.

Community Outreach

Giving back to our community is a strong tradition of the Inns of Court and the Pittsburgh Bar. Last year we had several Inn members participate in the Intel International Science and Engineering Fair. For example, Richard Graham served as a Grand Award Judge for the Robotics and Intelligent Machines, or ROBO, category of the Fair. He reported that the Fair involved what he described as a very "impressive collection of young minds, many hundreds of students between 9th and 12th grade from all over the world competing in 20 different categories." Although the Fair will not be back in Pittsburgh until 2018, we plan to continue this tradition of involvement and will roll out a voluntary community outreach program this fall. Richard Ting and Bryan Clark have been appointed our Inn's Community Outreach Co-Chairs and we look forward to hearing from them soon on this program.

The Linn Inn Alliance

As of this year, there are 24 IP Inns of Court across the country, which together form the Linn Inn Alliance. As a member of the Q.
