NUTS AND BOLTS OF VOIRE DIRE

Mr. Lane was heading east on a two way street with bicycle lanes on each side of the roadway. Mr. LaLane saw a vehicle coming towards him with his left turn signal illuminated. Mr. LaLane assumed that the vehicle had seen him coming and accelerated to clear the intersection.

Meanwhile, Mr. Fred Mertz was proceeding west bound in his 2009 silver Prius. The sun was particularly bright that day as he headed west. Mr. Mertz slowed and put on his blinker to make the turn. Not seeing any other vehicles approaching, Mr. Mertz began his turn. When he was crossing the bike lane and almost through the turn he heard a thump and saw something to his right.

Mr. Mertz discovered after he came to a stop that Mr. LaLane was lying in the roadway in a nonresponsive manner.

Mr. LaLane later claims to have suffered a head injury, lost of cognitive abilities in addition to aggravation of the pre-existing degenerative problems of the cervical area. Mr. LaLane is scientist that claims he was unable to work for over a year.

At the time of the accident, Mr. Mertz was 88 years old in good health. A year prior to the accident, Mr. Mertz had fall and fractured his hip. He had recovered. Six months after the accident Mr. Mertz had heart issues and lost his hearing. He gave up driving some 18 months after the accident. He will be able to attend the trial with the aid of his walker.

Mr. Mertz asserts a comparative negligence claim on the basis that the plaintiff had plenty of time to stop prior to the contact.
