<u>Peaches' Party in Washington DC</u> <u>Makes for an Interesting U.S. Supreme Court Case</u>

In March 2008 "Peaches", who is also known as "Tasty", threw a wild house party — in a vacant home in Northeast D.C. As often happens, a neighbor called the police who responded to the residence. One of the partygoers opened the door and the police entered to find drugs and alcohol. The officers observed a make-shift "strip club" downstairs and "more debauchery" upstairs. All 21 partygoers were arrested and ultimately 16 of them sued the District and five arresting officers for false arrest claiming that they were arrested without probable cause. So, the big question is: how does this case wind up in the Supreme Court of the United States? Simple, because the matter occurred in Washington D.C.: therefore, the trial court was the District Court; the intermediate Court was the D.C. Circuit Court of Appeal; and the next court was the Supreme Court of the United States!

PRESIDENT'S MESSAGE

I was confident that I would not make it. No one could convince me for almost 25 years that if I got on a plane, I would not die – simply cease to exist. My biggest fear realized because I decided to "go for it." After 25 years of sheer terror, I conquered my fear. It took the right mindset, dedication, focus, and lots of practice. We face things in our lives everyday that cause fear. In fact, studies show that fear of public speaking is America's biggest phobia, coming in at about 25%. I remember back in law school when I participated in an internship program with the City of St. Petersburg. I was heading to court with one of the City Attorneys to "argue" an uncontested quite title action on an abandoned parcel of property within the city. Two cases were on the docket and we got to the Judge's chambers first and signed the sign-in sheet. Well, we wound up going second as I was gripped by fear hiding out in the ladies' room trying to calm myself down! Coming out of that hearing, I felt like a champ, I killed that hearing and title was, in fact, quieted in favor of the city! Over twenty years later, I

can barely recall that feeling. Why and when did this shift occur? Well, I just keep walking into the courtroom, over and over again, hearings, trials, UMC's – lots of practice! This got me to thinking that no matter what our biggest fear is, we can overcome it; just like I did with going into the courtroom and getting onto a plane.

Our Inn is uniquely designed to provide for diversity amongst years of practice, type of practice, and area of practice. We have Student/Pupil members from Nova University Shepard Broad College of Law; Associates with up to 5 years of practice; Barristers with 5-14 years of practice; and Masters/Judges with 15+ years of practice. And, that's what we do – "practice" law. While a Pupil or Associate Inn member may have a fear of arguing before the Court her first time, a Barrister or Master may have a fear of switching law firms, starting her own firm, or drafting her first appeal. There are all different situations which are new to us, it is our mindset, tenacity, and fortitude which determine how we will handle each new challenge we encounter.

Not only do the Inns of Court provide us with an opportunity to have new experiences that we may not otherwise have in our regular work week, we have the ability to interact with other members who have other life experiences and skill sets. In fact, one great friend of mine from the Inn has a husband who is a pilot. While not law related, she was supportive of my journey to overcome the flying phobia that crippled me for decades.

It is not only the members and mentors that can make a difference in facing your challenges, but also the opportunities provided by the Inn. There are many different leadership positions which can expose you to new and unique tasks that you may have never had an opportunity to undertake previously. In fact, I amazed myself by working on our INN the Know newsletter and learning how to use the Microsoft Publisher program – something I would not otherwise have even attempted to do previously.

After you have finished reading this edition of INN the Know, take a moment, close your eyes, and think about what is holding you back. What do you want to do, try, accomplish? And, what is stopping you from moving forward in pursuing that goal? What hidden fear do you have that may be preventing you from trying to do something you have never done before? Whatever it is, focus on it and develop an understanding of what it is that you need to conquer to move forward from where you are today. Ask for help and educate yourself with the assistance of friends, colleagues, mentors, and other Inn members, so that you can both reach, and far exceed, the achievements that you set for yourself. I asked for, and received, the assistance of a former commercial airline pilot turned LCSW who has helped thousands overcome their fear of flying. I know that if I can not only get on an airplane, but also enjoy the flight, that you can do anything you can imagine. I hope you all exceed beyond your wildest dreams and face, head on, any obstacle in your way, and any fear that you may have within you.

Recipe of the Month: STROMBOLI

Enjoyed by all at our October dinner, this delicious Italian dish can be made with unlimited goodies inside:



INGREDIENTS

- 1 Publix Pizza dough from the Bakery 1 hot or mild Italian Sausage (not in casing)** 5 Italian Cheese Blend
- 2 pkgs Frozen Chopped Spinach Salt and Black Pepper
- **For vegetarian option, you can use non-meat sausage substitute or any mixture of sautéed veggies—think mushrooms, peppers, artichoke, zucchini, eggplant, etc!

PREPARATION

Preheat oven to 350 degrees; If in casings remove and Sauté Sausage in pan. When browned, drain grease. Thaw Spinach or defrost in microwave and squeeze out all water with your hands in a colander.

**If using veggie sausage substitute or other veggies, Sauté in pan with 1 Tablespoon of oil.

Spray cookie sheet with non-stick veg. spray; Roll Pizza dough out with Rolling Pin and transfer pizza dough onto cookie sheet; Sprinkle dough with sautéed sausage; then sprinkle with Spinach & Cheese blend over sausage chunks; add salt and pepper over all; Roll in jelly roll fashion, seal edges and brush olive oil on top of loaf

Bake at 350 degrees for one hour. Let cool 20-30 minutes before slicing into 1-2 inch slices and enjoy!

About 4-6 servings.


