### Special note on 2020-2021 dues

WVAIC seeks to build and retain a diverse membership of legal practitioners. The WVAIC board recognizes that the up-front cost of dues may impact some practitioners' ability to become or remain a member. After evaluating this year's anticipated income and expenses in light of COVID-19 and the 2020 Needs & Values Survey responses, the board is taking the following steps to balance accessibility to membership with costs to the Inn:

- (1) providing a new option to pay by credit card (yes, checks will still be accepted);
- (2) offering an optional 20% COVID-19 related discount to all membership levels; and
- (3) offering additional options for individuals to seek a cost reduction or deferral, or to contribute a sponsorship amount.
