INTRODUCTION

Welcome to the 2020-2021 program year of the Rodney Inn of Court!

The Rodney Inn is Delaware's general litigation Inn and our members have diverse professional backgrounds and professional experience. Our mission mirrors that of our parent organization, the American Inns of Court, to "foster excellence in professionalism, ethics, civility and legal skills." Inn membership affords rewarding professional development and mentoring opportunities, while providing CLE credits. Our Inn includes judges (both state and federal), lawyers (both private sector and government service — including civil and criminal), and law students.

In light of COVID-19, this year's program will look different from years past. Because the safety and well-being of our Inn members and our communities is a top priority, the Inn will hold virtual meetings through 2020. The plan for 2021 remains undecided at this time. The Executive Committee will continue to monitor COVID-19 developments and provide a mid-year update with the Inn's plan for 2021 meetings and events. In the meantime, I invite you to review the Rodney Inn Handbook for details regarding changes to Inn meetings, adjustments to dues, and virtual meeting information.

The Executive Committee is pleased to offer an interesting substantive program that we hope will help you improve your litigation skills and knowledge of current legal issues that face our community. While providing excellent CLE programming is always a goal, we hope to continue to reinvigorate the Inn's mentoring goals. In 2017, we reorganized the litigation groups to increase the mentoring opportunities available to less experienced Inn members. We hope these smaller groups will foster increased exposure between more experienced Inn members and less experienced Inn members. This revised structure should also continue to allow for increased participation by all in the CLE presentations.

Some Inn members have been assigned to "emeritus" status instead of being assigned to a litigation group. These assignments were based upon each member's attendance (or lack of attendance) during the last program year cycle (program year cycles are now two years). Participation in the presentation of a CLE program and attendance at events throughout the program year are strongly encouraged. Nevertheless, we understand that any member's personal and/or professional obligations might prevent full participation in any given program year. Accordingly, the assignment to a litigation group or to emeritus status continues to be for one year only and assignments will continue to be re-evaluated each year.

The members of the Executive Committee hope that membership in the Rodney Inn will be rewarding and worthwhile for each Inn member. Please do not hesitate to contact me, or any Executive Committee member, if you have any suggestions for improvements we might make.

MISSION AND GOALS OF THE AMERICAN INNS OF COURT

The Mission of the American Inns of Court is to foster excellence in professionalism, ethics, civility, and legal skills.

Goals

1. To promote, establish and charter American Inns of Court throughout the United States.
2. To help ensure the vitality and continuity of local Inns.
3. To facilitate the exchange of ideas, experiences and ongoing education among members of the American Inns of Court, thereby maintaining an institutional forum where judges, lawyers, academicians and students of law, working together, pursue the highest goals of the legal profession.
4. To shape a culture of excellence in American jurisprudence by promoting a commitment to professionalism, ethics, civility and legal skills in the practice of law, and transmitting these values from one generation of lawyers to the next.
5. To ensure the viability and long-term stability of the American Inns of Court Foundation.

PROFESSIONAL CREED

Whereas, the Rule of Law is essential to preserving and protecting the rights and liberties of a free people; and

Whereas, throughout history, lawyers and judges have preserved, protected and defended the Rule of Law in order to ensure justice for all; and

Whereas, preservation and promulgation of the highest standards of excellence in professionalism, ethics, civility, and legal skills are essential to achieving justice under the Rule of Law;

Now therefore, as a member of an American Inn of Court, I hereby adopt this professional creed with a pledge to honor its principles and practices:

- I will treat the practice of law as a learned profession and will uphold the standards of the profession with dignity, civility and courtesy.
- I will value my integrity above all. My word is my bond.
- I will develop my practice with dignity and will be mindful in my communications with the public that what is constitutionally permissible may not be professionally appropriate.
- I will serve as an officer of the court, encouraging respect for the law in all that I do and avoiding abuse or misuse of the law, its procedures, its participants and its processes.
- I will represent the interests of my client with vigor and will seek the most expeditious and least costly solutions to problems, resolving disputes through negotiation whenever possible.
- I will work continuously to attain the highest level of knowledge and skill in the areas of the law in which I practice.
- I will contribute time and resources to public service, charitable activities and pro bono work.
- I will work to make the legal system more accessible, responsive and effective.
- I will honor the requirements, the spirit and the intent of the applicable rules or codes of professional conduct for my jurisdiction, and will encourage others to do the same.

OVERVIEW OF THE RICHARD S. RODNEY INN OF COURT

The Richard S. Rodney Inn of Court was founded in 1985 – the 17th American Inn of Court chartered in the United States – with United States District Judge James L. Latchum as its first President. It is named in honor of Judge Richard S. Rodney, whose biographical sketch follows.

The Honorable Richard Rodney Cooch, Judge Rodney's grandson, wrote the following account of his grandfather, which appeared in the Spring 1994 edition of Delaware Lawyer magazine:

Richard Seymour Rodney was born October 10, 1882 in New Castle, Delaware, where he resided until his death on December 22, 1963. He was descended from George Read, signer of the Declaration of Independence as well as of the United States Constitution, and from numerous early Delaware lawyers and judges. He had a lifelong love of people, history, and the law. He served for 24 years (1922-1946) as an Associate Judge of the State of Delaware and for 17 years (1946-1963) as a United States District Court Judge for the District of Delaware.

He was also involved in many aspects of town and State service. He served on the Vestry of Immanuel Church in New Castle for 57 years, was a founder of St. Andrew's School, was Mayor of New Castle for three terms, served as a Trustee of the New Castle Common for over half a century, and was President of both the New Castle Historical Society and the Historical Society of Delaware.

However, mere recitation of his judicial service and other accomplishments does not paint the complete picture of Judge Rodney. Speaking on behalf of the Delaware Bar Association, William S. Potter, Esquire said of Judge Rodney at proceedings in his memory in the Delaware Supreme Court on January 31, 1964 (269 A.2d 7):

“His quick and incisive mind, his deep human understanding, his superb sense of justice, left an enduring imprint on the product of his Court. Over and beyond these qualities were the integrity, gentleness and compassion with which he discharged his judicial duties.”

Chief Judge John Biggs, Jr. of the Third Circuit Court of Appeals perhaps summed up the feelings of the Bench and Bar of Delaware when, at that same proceeding, he said:

“All departed judges belong to the past. Only a few – a very few of them – belong to posterity. Judge Rodney is one of that small group. His face, his figure, his graciousness, his generosity, his wisdom, will not be forgotten by those of us who knew him. But what of those members of our bench and bar who will follow us and who will never know him?”

DIVERSITY POLICY OF THE RICHARD S. RODNEY INN OF COURT

The Richard S. Rodney Inn of Court supports and adopts the American Inns of Court Diversity Policy (the “Diversity Policy”). The Diversity Policy states:

The American Inns of Court Embraces and Encourages Diversity and Inclusiveness.

More than just an organization, the American Inns of Court is the embodiment of an ideal. We are dedicated to upholding the standards of the legal profession, to practicing law with dignity and respect, and to encouraging respect for our system of justice. Achieving a higher level of excellence and developing a deeper sense of professionalism occur only with an abiding commitment to the goals of diversity and inclusiveness.

The American Inns of Court firmly believes that personal diversity in all its aspects is essential to our ability to accomplish our mission. Diversity embodies all those differences that make us unique individuals and includes people of different race, ethnicity, culture, sexual orientation, gender, religion, age, personal style, appearance, physical ability as well as people of diverse opinions, perspectives, lifestyles, ideas and thinking. We value the differences in views and perspectives and the varied experiences that are part of a diverse membership. Diversity enriches and broadens our membership, which in turn leads to more creative and meaningful programs.

For the same reasons, the American Inns of Court values professional diversity. Legal professionals and law school faculty, administrators, and students, from all disciplines, from all practice types, from both the public and private sectors, from all economic strata, and from the least experienced to the most seasoned are vital to maximizing the Inn experience. Only by drawing and retaining a diverse membership will we guarantee the success of our unique organization as well as our respective professional pursuits. Therefore, the American Inns of Court are committed to creating and maintaining a culture that promotes and supports diversity not only throughout our organization, but in our profession as well.

The Rodney Inn promotes the Diversity Policy in the following ways:

1. The Rodney Inn includes a link on its webpage (<http://inns.innsocourt.org/for-members/inns/the-richard-s-rodney-american-inn-of-court.aspx>) to the Diversity Policy.
2. The Rodney Inn's Executive Committee members are nominated and elected, among other factors, based upon diversity enrichment and leadership.
3. The Rodney Inn provides discounted membership rates for public sector employees and law students and encourages membership by these groups.
4. The Rodney Inn's community outreach programs are aimed at diverse segments of its community.
5. The Rodney Inn also expands upon the Diversity Policy by incorporating gender identity, gender expression and socioeconomic diversity in its policy.

PUPILAGE GROUPS

The Inn is organized into pupilage groups. Each group is composed of Master/Benchers, including Judges and experienced attorneys, Barristers, and Pupils. Currently, there are eight pupilage groups: Gray, Seitz, Tunnell, Woolley, Young, Latchum, Carpenter and Schwartz.

The **Gray Group** is named for Judge George Gray, the first Delawarean to be appointed to the United States Court of Appeals for the Third Circuit after its formation in 1891. Judge Gray served on the Third Circuit from 1899 to 1914. Prior to his appointment, Judge Gray had been the Attorney General of Delaware for six years and then United States Senator from 1885 to 1899.

The **Seitz Group** is named for Judge Collins J. Seitz, Sr. Judge Seitz began his judicial career as a Vice Chancellor of the Delaware Court of Chancery in 1946 at age 31, making him the youngest judge in Delaware in over a century. He became Chancellor in 1951, and served on the Court of Chancery until 1966, when he accepted President Johnson's nomination to the United States Court of Appeals for the Third Circuit. Judge Seitz served as Chief Judge of that Court for thirteen years, and remained on the Bench until he passed away on October 16, 1998.

The **Tunnell Group** is named for Justice James M. Tunnell, Jr., one of the first Justices to serve on the Delaware Supreme Court upon its creation in 1951. Justice Tunnell served on the Court for three years, authoring its first reported opinion. He resigned in 1954 to seek nomination for the United States Senate and became a noted advocate with the law firm of Morris, Nichols, Arsht & Tunnell.

The **Woolley Group** is named for Judge Victor B. Woolley, who succeeded Judge Gray on the United States Court of Appeals for the Third Circuit in 1914. Prior to joining that Court, Judge Woolley was an Associate Judge of the Delaware Superior Court. Judge Woolley was an active member of the Third Circuit from 1914 until he took senior status in 1938. Judge Woolley wrote the two-volume treatise *Practice in Civil Actions and Proceedings in the Law Courts of the State of Delaware*, which is frequently referred to by judges and practitioners.

The **Young Group** is named for H. Albert Young, Esquire, who served as Delaware's Attorney General from 1951 to 1955 and was chosen by the party states in *Brown v. Board of Education* to argue their case before the United States Supreme Court. He was the last Attorney General to personally prosecute all of the capital cases coming through his office. Rather than seeking a second term as Attorney General, Mr. Young returned to private practice and became a founder of the law firm of Young, Conaway, Stargatt and Taylor.

The **Latchum Group** is named for Judge James L. Latchum, who succeeded Judge Caleb R. Layton, III on the United States District Court for the District of Delaware. He served as an active judge until the end of 1983, including a term as chief judge from 1973 to 1983, and as a senior judge until his passing on January 31, 2004. Widely respected for

his wit and wisdom, Judge Latchum was the founding president of the Rodney Inn of Court and was instrumental in gathering support within the bench and bar for the formation of the Inn. He chose to name the Inn for Judge Richard S. Rodney because of his great appreciation for Judge Rodney's example of excellence and civility on the bench.

The **Schwartz Group** is named for Judge Murray M. Schwartz. He was a law clerk to Judge Caleb M. Wright and, after Judge Wright took senior status in 1973, was confirmed as Judge Wright's successor in 1974. He was the chief judge from 1985 until 1989, when he assumed senior status. Judge Schwartz had also served as a Referee in Bankruptcy from 1969-74. He passed away on January 11, 2013. For his courage and skill in addressing contentious and difficult cases, including the school desegregation litigation and the prison overcrowding litigation, he earned the respect even of those who disagreed with his rulings.

The **Carpenter Group** is named for Edmund N. (Ned) Carpenter, II, a former partner at Richards, Layton & Finger, P.A. Ned was one of the leaders of the Delaware Bar who was instrumental in forming the Rodney Inn of Court. In addition to being one of the premier litigators in Delaware history, Ned was a decorated World War II hero who embodied all the desired traits of a senior Inn member -- exceptional legal skills combined with exemplary professionalism and civility.

HISTORY OF THE AMERICAN INNS OF COURT

The American Inns of Court (“AIC”) concept was the product of a discussion in the late 1970s among the United States’ members of the Anglo-American exchange of lawyers and judges, including Chief Justice Warren E. Burger and Chief Judge of the Ninth Circuit J. Clifford Wallace. Chief Justice Burger subsequently invited Rex E. Lee (then Dean of the J. Reuben Clark School of Law at Brigham Young University and later United States Solicitor General) and Dallin Oaks (then president of Brigham Young University and later Justice of the Utah Supreme Court) to test the idea.

At the suggestion of Rex Lee, a pilot program was entrusted to Senior United States District Court Judge A. Sherman Christensen, who honed the idea into a feasible concept. The first American Inn of Court was founded in 1980 in the Provo/Salt Lake City area of Utah, and included law students from Brigham Young University.

In 1983, Chief Justice Burger created a committee of the Judicial Conference of the United States to explore whether the American Inn concept was of value to the administration of justice and, if so, whether there should be a national organization to promote, establish and assist American Inns, and promote the goals of legal excellence, civility, professionalism and ethics on a national level. The committee reported to the Judicial Conference affirmatively on the two questions and proposed the creation of the American Inns of Court Foundation. The Judicial Conference approved the reports, and thus endorsed the American Inn concept and the formation of a national structure. In 1985, the same year that the Richard S. Rodney Inn of Court was formed, the American Inns of Court Foundation was formally organized. The American Inns of Court movement has grown faster than any other organization of legal professionals, with over 300 Inns.

The American Inns of Court Foundation has several objectives – support the local Inn; assist, encourage and charter new Inns nationwide; serve and foster communication between Inns; and encourage membership in the American Inns of Court. The Foundation provides services and benefits to Inn officers and members to accomplish these objectives. For further details, please visit the AICF web site at www.innsocourt.org.

MEMBERSHIP CATEGORIES

Masters of the Bench: Benchers/Masters are appellate and trial judges, both federal and state, as well as lawyers with approximately fifteen or more years of experience and of demonstrated superior character, ability and competence.

Barristers: Lawyers who have approximately five to fifteen years of experience in the practice of law are Barristers.

Associates: Lawyers who are new to the profession and do not reach the minimum qualifications for Barrister are considered Associates.

Law Students: Students who are enrolled and attending classes at Delaware Law School of Widener University or other regional law schools.

Emeritus: Lawyers, designated as Masters, Barristers or Associates, who have been assigned to this category for one year, by request or based upon previous attendance. Assignments to Emeritus status will be re-evaluated each year. Please note that all members are encouraged to maintain active participation as Masters, Barristers, Associates or Law Students.

INVITATIONS TO MEMBERSHIP

The Executive Committee extends invitations for membership each summer. In extending invitations to renew membership, the Executive Committee considers the participation and attendance of members during the preceding year. The Executive Committee keeps track of attendance according to the sign-in sheet/bar card scanner that is provided at substantive in-person meetings, or via the Zoom app for virtual meetings. It is, therefore, recommended that all members scan their bar card or sign the sign-in sheet when they attend in-person meetings, or log in to the Zoom app rather than dial in by phone so that the Executive Committee has a record of their attendance. If you dial in to virtual meetings by phone only, the Inn will not have a record of your attendance and cannot verify your attendance for CLE credit purposes.

In extending membership to potential new members, the Executive Committee does so after considering a nomination for membership that it receives from a current member or a request for membership it receives by the prospective new member. Individuals wishing to join the Rodney Inn must have a sponsor who is a current member. All new members will automatically be assigned “Emeritus” status until the next program cycle.

The Executive Committee invites a certain number of student members each year for a one-year term based on a recommendation received by a designated faculty/staff member of Widener University School of Law. In order to afford as many students as possible an opportunity to participate in the Rodney Inn, the Executive Committee does not renew student memberships unless a specific request to do so is made. If a student member wishes to participate as an associate member after their law school graduation, the Executive Committee will consider their membership upon receipt of a nomination for their membership from a current member or a request from the student member.

ANNUAL DUES

In light of COVID-19, the Inn will hold virtual meetings through 2020. As a result, the dues for this Inn year have been reduced. **Please note that dues should be submitted by check on or before October 21, 2020, as follows:**

III. Associates (Lawyers with 0-4 years of experience)

- c. Law Clerks: dues are waived for 2020-2021 Inn year

IV. Law Students: dues are waived for 2020-2021 Inn year

ATTENDANCE REQUIREMENTS

The Executive Committee encourages members to take seriously their commitment to the Inn. Each member's attendance at and participation in the Inn's regularly scheduled programs is vital to the continued success of the Inn, and to fostering an atmosphere of mutual support and camaraderie.

If you cannot attend an Inn meeting or event, you may designate a substitute to attend in your absence. Each member shall be permitted to send one substitute to one meeting or event per Inn year. Requests to designate a substitute for additional meetings or events will not be permitted. The Executive Committee encourages members to provide the opportunity to attend an Inn event as a substitute to more junior members of the bar. You must notify the Executive Committee, specifically Eve Ormerod (eho@skjlaw.com), of your intention to send a substitute prior to the day of the event.

If for some reason you cannot attend a meeting, please make every effort to notify the Executive Committee, specifically Eve Ormerod (eho@skjlaw.com) and Mackenzie Wrobel (mmwrobel@duanemorris.com).

MEETINGS AND PROGRAMS

Each pupillage group should coordinate with a member of the Programming Committee to ensure that the group's proposed program is designed to involve all members of the pupillage group. Pupillage groups should prepare written materials and handouts relevant to their programs and allow adequate time for discussion by members of points raised in the programs.

CLE CREDIT

The Richard S. Rodney Inn of Court applies for Delaware and Pennsylvania Continuing Legal Education (CLE) credit for its members, usually consisting of 1.0 hours of credit (including a substantive ethics component when appropriate). In order to obtain CLE credit, members must sign the attendance sheet or scan their bar card at each in-person Program Meeting, or log in to the Zoom app rather than dial in by phone so that the Executive Committee has a record of their attendance. If you dial in to virtual meetings by phone only, the Inn will not have a record of your attendance and cannot verify your attendance for CLE credit purposes.
