The Chief Justice Thomas J. Moyer Inn is a part of The American Inns of Court Foundation, which is America's oldest, largest and fastest growing legal mentoring organization. Our meetings are usually held on the second Wednesday of each month, September through May, with the exception of December (no meeting) at the Graystone Wine Cellar in the Brewery District. Our in-person meetings (when safe to do so) begin with socializing at 5:30 p.m., followed by dinner from 6:00 to 6:45 p.m., and conclude with an hour-and-a-half-long continuing legal education program. Each team, guided by a team leader, is responsible for developing one of the programs each year.
