Laura has served as chair, wing, and solo arbitrator on over one hundred commercial, IP, patent, software, medical device, and drug development disputes as well as telecom disputes of all kinds, including billing disputes among carriers. She has mediated more that 300 matters, including international trademark disputes, patent and IP disputes, family business disputes, business disruption cases and other insurance disputes, commercial property disputes, employment and securities matters and a wide variety of complex contract disputes.

Laura is a past Chair of the NYSBA Dispute Resolution Section 2020-2021. From 2015-2017, Laura was the President of the Justice Marie L. Garibaldi ADR Inn of Court, the first ADR Inn in the country. She is also a past Chair of the NJSBA Dispute Resolution Section and a Co-Editor in Chief of the NYSBA's journal, Dispute Resolution Lawyer. She is the 2018 recipient of the Jeydel Award from the Garibaldi Inn for ADR Excellence and Civility and the 2014 recipient of the NJSBA's Boskey Award for the ADR practitioner of the year. She is a co-author on chapters in Halket, The Arbitration of International IP Disputes 2 ed.
