Membership is divided into the following categories:

- 1) **Pupils** - \$200 (law students),
- 2) **Associates**- \$350 (admitted to the Bar less than 5 years),
- 3) **Barristers** - \$400 (attorneys admitted to the Bar between 5 and 15 years),
- 4) **Masters** - \$450 (attorneys admitted to the Bar more than 15 years), and
- 5) **Judges** - \$375 (also referred to as Benchers)
- 6) **General Magistrates, Hearing Officers, and Government Attorneys** - \$300 (includes attorneys with Bay Area Legal Services)
- 7) **Guests**- \$50 per meeting

Included in the membership fee are the following:

- Eight complete dinners at the Chester H. Ferguson Law Center, and a holiday party in December. One of the dinners is a special joint meeting with the Canakar Family Law Inn and the judges of the 2<sup>nd</sup> District Court of Appeals.
