1. MDA Muscle Walk

The Muscular Dystrophy Association's local DC/VA chapter will be holding its annual "Muscle Walk" at George Mason University on April 2, 2011 complete with food, activities, face painting for the kids, a photo booth, and more. This year's "carnival" kicks off with a four-lap walk around the Athletic Field House's indoor track followed by a raffle of prizes and the presentation of fundraising awards.
