Purpose of the SCRA

To provide for, strengthen and expedite the national defense through protection extended by this Act to Servicemembers of the United States to enable such persons to devote their entire energy to the defense needs of the Nation; and

To provide for the temporary suspension of judicial and administrative proceedings and transactions that may adversely affect the civil rights of Service-members during their military service.

Servicemembers Civil Relief Act Enacted on December 19, 2003 SCRA was written to: · Clarify the language of SSCRA · Incorporate and codify years of judicial interpretation of SSCRA · Reflect developments in American life since 1940 Revised in 2004 and 2008 SCRA Organization · Title I - General Provisions · Title II - General Relief · Title III - Rent, Installment Contracts, Mortgages, Liens, Assignment, Leases · Title IV - Life Insurance · Title V – Taxes and Public Lands · Title VI - Administrative Remedies · Title VII - Further Relief Definitions - § 511 Servicemember · Active Duty Service of the Five Service Branches · Includes National Guard and Reserves mobilized for federal active duty service, and during annual training and military schooling · National Guard under military orders for 30+ days during a President-declared national emergency · Public Health Service & Nat'l Oceanic & Atmospheric Officers · Dependent SM's spouse or child • Person that SM provided more than 1/2 support for 180 days preceding application for relief under Act.

SCRA Military Status Analysis

- 1. Is individual is a SM?
- Is SM part of active duty military, the Reserves or National Guard?
 - Full-time Reserves or NG does not equate to active duty military.
- 3. If AC, SCRA applies.
- If Reserves or NG, no SCRA protection—unless performing active duty service, as defined by SCRA and 10 USC 101(d)1
 - a. mobilized for federal service
 - b. annual training
 - c. military schooling
 - d. national emergency for 30+ days (NG only)

Definitions - § 511

- · Court includes:
 - All courts—including bankruptcy
 - · All administrative agencies
 - A large expansion of coverage under SCRA
 - · Whether or not of record
- Judgment defined as any judgment, decree, order, or ruling, final or temporary
 - · Not just final judgments
 - Veterans Benefits Improvement Act of 2004

Waiver of SCRA Rights - § 517 · SM may waive protections · Must be in writing · Modification, Termination or Cancellation · Contract, lease or bailment · Mortgage, trust, deed, lien, other security · (Re)possession, retention, foreclosure, sale, forfeiture of property that is security for an obligation · Must be executed as an instrument separate from obligation or liability to which it applies · Must be made during or after period of service Legal Representatives - § 519 · SCRA adds a provision recognizing a legal representative of SM: · An attorney acting on the behalf of SM; or · An individual possessing a power of attorney · Legal Representative can take same actions as SM Default Judgments - § 521 · Applies if Defendant has not appeared · Plaintiff's affidavit must state: · Whether Defendant is in military; or · If unable to determine status, court may require Plaintiff to post bond · If Defendant is a SM, court cannot enter default judgment until counsel is appointed to represent SM Query - Appointed counsel's duties? Who pays?

Default Judgment Stay - § 521 . If Defendant is in military, court will stay proceedings · Upon request of legal counsel or court's own motion · Minimum 90-day stay · Court first must determine: · A defense may exist that cannot be presented without defendant's presence; or · After due diligence, legal counsel has been unable to contact defendant or otherwise determine if a meritorious defense exists · § 522 Stay of Proceedings provision not applicable Setting Aside Default Judgments - § 521 · Court will re-open default judgment entered while SM on active duty or within 60 days thereafter, when SM applies for relief during military service or within 9 months thereafter and shows: · Material effect of service to defend; and · Meritorious defense · Bona Fide purchasers protected * Housing and Economic Recovery Act (HERA) 2008 extended protection to 9 months, which reverts back to 90 days on Jan. 1, 2011. Stay of Proceedings - § 522 Temporary delay in civil actions until SM can appear During period of service, plus 90 days · SM has received notice of proceeding · Mandatory 90-day stay if: · SM states how military service materially affects ability to appear and date when SM can appear · Commanding officer confirms duty precludes SM appearance and leave not authorized · Not an appearance for jurisdictional purposes and does not waive

any substantive or procedural defense-including lack of personal

2008 Defense Authorization Act changed SCRA to expressly apply

to child custody cases

Stay of Proceedings - § 522 Extension of Stay

- · SM may apply for additional stay based on continuing material effect of military duty on SM's ability to prosecute or defend the action
- · If Court does not grant additional stay, it shall appoint counsel to represent SM
- · Provision applies to SM, both as plaintiff and defendant

Query - Appointed counsel's duties? Who pays fees?

Stay of Proceedings - § 523 Fines and Penalties

- · No penalties under a contract if performance stayed by court, and if no stay:
 - · Court may reduce or waive fine or penalty if:
 - · SM was in military service at time of fine/penalty
 - · Performance materially affected by military service

Stay or Vacation of Judgments - § 524

- · If military service materially affects compliance with judgment/order, court shall upon SM request, or may upon own motion:
 - · Stay execution; and
 - · Vacate or stay attachment or garnishment
- · Applicable to action commenced against SM before or during military service or within 90 days afterwards

Stay or Vacation of Judgments Duration of Stays - § 525

- · May be for period of military service, plus 90 days, or any part thereof
- · Court may set terms and amount of any installment payments
- · Plaintiff may proceed against any co-defendants not in military service with court approval

Statute of Limitations - § 526

- · Period of military service NOT included:
 - · In any period limited by law, regulation or order to bring any action or proceeding
 - · Including redemption of real property
 - · By or against SM, heirs or assigns
- · Does not apply to IRS
- · Material effect NOT required.

Evictions & Distress - § 531

- · Can only evict upon Court order: No self help
 - · Applies to SM or dependents
 - · Residential rent does not exceed \$ 2,615 (2006)
 - · Adjusted periodically for inflation
 - · Ability to pay materially affected by service
- · Court shall stay for minimum of 90 days or adjust lease obligations
- · Criminal sanctions for violation
- · Dependents have right to invoke

Installment Contracts for Purchase or Lease - § 532

- · Contract for purchase, lease, or bailment of real / personal property
 - · Payment or deposit made prior to military service
- · If SM breaches Pre-service contract before or during military service, Creditor must have Court order to terminate contract/repossess property. Court may:
 - · Order repayment to SM by Creditor to terminate contract or repossess property
 - · On its own motion, and shall at SM's request, stay proceedings if SM's ability to comply is materially affected
 - · Make other equitable disposition to preserve interests of parties
- · Misdemeanor offense for violation

Mortgage Foreclosure Protection - § 533

- · Applies to any action to enforce pre-service obligation on real or personal property secured by a mortgage, trust deed, etc.
- · Court may—and shall upon SM request—after a hearing and upon showing of material effect:
 - · Stay proceedings; or
 - · Adjust obligation
- Lender must obtain Court order to sale, foreclose or seize property because of a breach of such an obligation
- * HERA 2008 expanded applicability period from military service + 90 days to military service + 9 months. Period will revert back on January 1, 2011

Enforcement of Storage Liens - § 537

- · Only Court-ordered enforcement is allowed
- · Applies to storage liens for any reason
- · Court shall stay or adjust the obligations of all parties upon SM request and ability to comply is materially affected
- · Court may do same on own motion
- · Misdemeanor violation if knowingly use self-help
- · Other remedies preserved

· For accurate inquiries, need name, SSN & DOB	
· Certificate of Service is free of charge
